RULES:

1. Teams shall consist of two (2) members and helmets must be worn by both members.
2. Only one (1) team member is allowed on the Chair Lugé during the race.
3. All Participants must sign the attached waiver. No one under the age of 16.
4. **Chair Lugé must be a homemade contraption with a definable chair: in the past we have had lawn chairs, lazy-boy recliners, plastic chairs and wooden chairs. The driver has to be able to sit on the seat. Chair Lugé maximum length is 8 Ft., with at least 3 wheels.**
5. Motors, or motorized vehicles, are not allowed
6. Go-carts, go-cart frames, riding lawn mowers and the like are not allowed.
7. **Braking and Steering systems are optional, but you must be able to demonstrate that you can stop your Lugé; if you cannot you will not be allowed to race.**
8. The Lugé pushers must stay within the "Launch Zone" (Approximately 5ft) and the "Warning Zone" (Approximately 3 Ft.) Noses of the Lugé must line up behind the "Warning Zone" line. Any team member that pushes the Lugé beyond the "Warning Zone" will be D/Q for that race.
9. Come early between 12:00 & 1:00pm Every Lugé will go through an inspection by the safety judge. The safety judge will have the final say if your Lugé will be allowed to race. If you are deemed ineligible to race you will have until 1:00PM to fix your Lugé.
